Under terms negotiated by Insurers, arrangements have been made for additional assistance to be provided to the Insured as follows:

## 1. Coverage Advice

1.1 Insurers have arranged for Reynolds Colman Bradley LLP, a firm of specialist solicitors, to be retained to provide legal advice at no additional charge for, the Insured as a benefit of the insurance policy, as to whether the terms of prospective contractual documentation including appointments, collateral warranties or novation agreements may give rise to issues impacting on the Insured's insurance policy ("Coverage Advice").

1.2 In cases where detailed examination of other contractual documentation is required for this purpose, for example, where other documentation such as building contracts, lease agreements, etc. are incorporated by reference into a draft appointment, the Insurers have arranged that Reynolds Colman Bradley LLP will provide this more extensive Coverage Advice, subject to the Insured making a contribution to the cost of such advice. The appropriate level of contribution will be between £195.00 and £250.00 per hour depending upon the value of the project and the complexity of the documentation. In those circumstances, upon receipt of an enquiry, Reynolds Colman Bradley LLP will inform the Insured of the time that any review is likely to take and of the relevant contribution rate, which is to be agreed with the Insured prior to fees being incurred.

## 2. Commercial Advice

2.1 In addition, should the Insured require more general commercial legal advice ("Commercial Advice") as to the terms of any documentation as is referred to above, this will be available at the same contribution rates of between £195.00 and £250.00 per hour depending upon the value of the project and the complexity of the documentation.
